SECTION A

- 1. Adeleke and Zainab are 200L LL.B students of Redeemers University, Ede. They got into a discussion after Constitutional Law class and eventually engaged in an argument. Adeleke is of the view that the concept of sovereignty is one of the most controversial concepts in political science and International Law jurisprudence, while Zainab completely disagreed with him. In the course of their argument, Adebayo appeared and quietly listened to their argument and shook his head and smiled and suddenly said "what exactly are you guys talking about?" Adebayo being a Theatre Art student asked the following questions:
 - a. Is the concept of sovereignty really associated with chromatic definitions?
 - b. In few sentences, examine the nuanced view on sovereignty by Jeremy Bentham that is embedded in his perspective on the concept.
 - c. In your considered opinion, is there a relationship between sovereignty and the people. Discuss, with the aid of relevant authorities.
- 2a. The idea of Parliamentary sovereignty tends to depart from the understanding of constitutional sovereignty, yet parliamentary sovereignty seems to assume the right to make or unmake any law whatsoever.
