1. I APPOINT Mr. Noble Bryan – Accountant, of the National Railway, 247 KM 4, King's Square, New York, and Mr. Kim George – Engineer, of the Royal Constructions, 5th Floor Beauty House, Central District, New York to be the EXECUTORS and TRUSTEES hereof.
2. I DECLARE that I shall be buried in Accord with the tenets of LIFE ORGANIZATION INTERNATIONAL (LOI) anywhere my wife, Darlyn SHAW decides. I give this direction so that she should not be subjected to any inconvenience or financial burden. She knows that I wish to be buried as simply as possible much as I lived a simple life as one of LIFE ORGANIZATION INTERNATIONAL (LOI).
3. I GIVE all my Real and Personal properties what-so-ever and where-so-ever including my pension fund and entitlements and benefits at my place of work to my

wife, Darlyn SHAW. We have two lovely daughters, Tulip and Hibiscus, and I am confident that she (my wife -Darlyn SHAW) will use the properties hereby devised and Bequeathed to her to educate them (our daughters, Tulip and Hibiscus) and give them a head start.
